Examination. Examine the person to determine the site of the lump and identify if it is associated with a particular structure. Look for signs of stridor or superior vena cava compression (swelling of the face and/or neck with fixed elevation of jugular venous pressure). Examine the neck. Look at the neck to identify visible masses and pulsation.
